Investment options performance as of April 30, 2024

These tables reflect the three-month return and average annual rates of return for each investment option within the Retirement Protector program. The effective date of the Retirement Protector is January 2, 2013. All results for periods prior to the stated inclusion dates are hypothetical performance and the results after those dates are actual performance of the investment options in the Retirement Protector program. Returns prior to the inception date of the investment option are based on the previous performance of other share classes of that investment option. This performance is representative of what the investment option would have produced because all share classes of an investment option invest in the same portfolio of securities.

The three-month return and average annual rates of return assume premiums were paid as of the beginning of the period indicated. The three-month return and average annual rates of return of each variable subaccount were adjusted for a 1.25 percent mortality and expense fee.
